Tip: Water Meter Modification due to Fire Sprinkler upgrade

### **What determines the actual meter size for Fire Supply?**

The required size for a dual purpose (domestic and fire sprinkler) meter is dependent upon evaluation of both the fire sprinkler system and the domestic supply demand. The City's Fire Department provides the oversight and review of residential fire sprinkler systems. A licensed Fire Sprinkler Designer must design the system to meet the water demand for its required fire sprinkler system.

The required standard is a 1-inch dual purpose water meter with a 2-inch service line from water main to meter, and 1-1/2-inch service line from meter to the building. The customer is responsible for the 1-1/2" service line from the meter to the building.

### **13.08.035 Water service modifications.**

A charge shall be paid by all persons requesting a modification to their water service.

The water modification will include any work from the water meter to the water main.

### **How much will it cost?**

The cost of the modification is determined by the City of Redmond's Water Maintenance and Operations Department. The maximum cost for a service modification can be up to \$7,500.00 plus the difference in dwelling square footage if increased beyond the home size range it was previously in.

### **How do I start the application process?**

Start by contacting Development Engineering and Construction Division at 425-556-2840 to request a cost estimate. Provide the plan case number, site address and/or tax parcel number.

1. Water Termination Application to terminate the old meter
2. Water Meter Application for the new water service

### **When are the fees due?**

Permit fees are due at permit issuance.

### **Who should I contact to schedule the modification once my permit is issued?**

To request the installation of your modification within the 90 day permit window:

- Call the Water Operations Division and request a start date. The division requires at least 15 working days of notice to desired install date.

- Provide the water meter permit number
- Provide contact name and tel #
- You will be contacted to arrange for the installation schedule.
