### **Comprehensive Plan and Zoning Code Amendments**

**Topic:** Marymoor Subarea Comprehensive Plan and Zoning Code Amendments including Local Center Designation

**Subject:** Comprehensive Plan and Zoning Code Amendments for the Marymoor Subarea are called for in, and build upon, the Southeast Redmond Neighborhood Plan (Ord. 2752, Ord. 2753 and Res. 1415). The amendments comprise Comprehensive Plan and Zoning Code (RZC) amendments for a land use transition strategy; Comprehensive Plan amendments – including amendments to transportation, water, and sewer functional plans adopted by references – and RZC amendments to establish infrastructure requirements; Comprehensive Plan and RZC amendments to establish the Marymoor Design District zones and related regulations such as general provisions, landscaping, outdoor storage, retail display and garbage and recycling enclosures, tree protection, and review procedures; RZC amendments for affordable housing such as to establish the amount and level of affordability that would be required for the Marymoor Subarea with use of Multi Family Tax Exemption (MFTE) – another alternative that may be considered is affordability requirement without use of MFTE; amendments to clarify other affordable housing RZC provisions; Comprehensive Plan amendments to designate the Marymoor Local Center as the only local center in Redmond and to amend related policies to reflect this designation; and corrections to RZC 21.08, Residential Regulations to allow for attached dwelling units consistent with Southeast Redmond Neighborhood Plan policy.
