


INTERGOVERNMENTAL COOPERATIVE PURCHASING AGREEMENT

Pursuant to Chapter 39.34 RCW and to other provisions of the law, the City of Issaquah, Washington, hereinafter called "Issaquah" and the City of Redmond, Washington, hereinafter called "Redmond", hereby agree to cooperative governmental purchasing upon the following terms and conditions.

1. Issaquah, in contracting for the purchase of goods and services for Issaquah, agrees to extend said contacts to Redmond to the extent permitted by law, and agreed upon by the parties hereto, and the supplier(s).
2. Issaquah will contract for the purchase of goods and services according to the laws and regulations governing purchases by Issaquah. Redmond accepts responsibility for compliance with any additional or varying laws and regulations governing purchases by or on behalf of Redmond.
3. A purchase by Redmond shall be effected by a purchase order from Redmond directed to the supplier or other party contracting to furnish goods or services to Issaquah.
4. Issaquah accepts no responsibility for the performance of any purchasing contract by the supplier, and accepts no responsibility for payment of the purchase price by Redmond.
5. Redmond reserves the right to contract independently for the purchase of any goods or services, with or without notice to Issaquah.
6. Issaquah reserves the right to exclude Redmond from any particular purchasing contract, with or without notice to Redmond.
7. This Agreement shall continue in force until canceled by either party, which cancellation may be effected by ten (10) days written notice to the other party.
8. This Agreement covers all Issaquah contracts.





2. Redmond will contract for the purchase of goods and services according to the laws and regulations governing purchases by Redmond. Issaquah accepts responsibility for compliance with any additional or varying laws and regulations governing purchases by or on behalf of Issaquah.
3. A purchase by Issaquah shall be effected by a purchase order from Issaquah directed to the supplier or other party contracting to furnish goods or services to Redmond.
4. Redmond accepts no responsibility for the performance of any purchasing contract by the supplier, and accepts no responsibility for payment of the purchase price by Issaquah.
5. Issaquah reserves the right to contract independently for the purchase of any goods or services, with or without notice to Redmond.
6. Redmond reserves the right to exclude Issaquah from any particular purchasing contract, with or without notice to Issaquah.
7. This Agreement shall continue in force until canceled by either party, which cancellation may be effected by ten (10) days written notice to the other party.
8. This Agreement covers all Redmond contracts.


