

# INTERGOVERNMENTAL COOPERATIVE PURCHASING AGREEMENT

Pursuant to Chapter 39.34 RCW and to other provisions of the law, the City of Redmond, Washington, hereinafter called "Redmond" and the City of Kirkland, Washington, hereinafter called "Kirkland", hereby agree to cooperative governmental purchasing upon the following terms and conditions.

1. Redmond, in contracting for the purchase of goods and services for Redmond, agrees to extend said contracts to Kirkland to the extent permitted by law, and agreed upon by the parties hereto, and the supplier(s).
2. Redmond will contract for the purchase of goods and services according to the laws and regulations governing purchases by Redmond. Kirkland accepts responsibility for compliance with any additional or varying laws and regulations governing purchases by or on behalf of Kirkland.
3. A purchase by Kirkland shall be effected by a purchase order from Kirkland directed to the supplier or other party contracting to furnish goods or services to Redmond.
4. Redmond accepts no responsibility for the performance of any purchasing contract by the supplier, and accepts no responsibility for payment of the purchase price by Kirkland.
5. Kirkland reserves the right to contract independently for the purchase of any goods or services, with or without notice to Redmond.
6. Redmond reserves the right to exclude Kirkland from any particular purchasing contract, with or without notice to Kirkland.
7. This Agreement shall continue in force until canceled by either party, which cancellation may be effected by ten (10) days written notice to the other party.
8. This Agreement covers all Redmond contracts.




**INTERGOVERNMENTAL COOPERATIVE



- 3) A purchase by Redmond shall be effected by a purchase order from Redmond, directed to the supplier or other party contracting to furnish goods or services to The City.
- 4) The City accepts no responsibility for the performance of any purchasing contract by the supplier, and accepts no responsibility for payment of the purchase price by Redmond.
- 5) Redmond reserves the right to contract independently for the purchase of any goods or services, with or without notice to The City.
- 6) The City reserves the right to exclude Redmond from any particular purchasing contract, with or without notice to Redmond.
- 7) This Agreement shall continue in force until canceled by either party, which cancellation may be effected by ten (10) days written notice to the other party.
- 8) This Agreement covers all City contracts.


